Beginning the first business day of January, the Dorr Township Parks Commission will begin accepting reservations for the park pavilions for the current year. Reservations will be made on a first come, first served basis by visiting the Township Office at 1683 142nd Avenue. Payment is required at the time the reservation is made.

- RESERVED GROUP MUST HAVE A COPY OF THE RESERVATION FORM ON SITE TO VERIFY USE.
- A PARK PAVILION USE PERMIT SHALL BE POSTED AT THE PARK SITE.
- GROUP RESERVATION PAVILION WILL BE HELD RESPONSIBLE FOR RESTORING THE AREA TO ITS ORIGINAL CONDITION.

IF AREA IS NOT CLEANED UP, THE DEPOSIT WILL BE FORFEITED.

DORR TOWNSHIP PARK RENTAL FEES/RULES & REGULATIONS

PARK FEES

NORTH PARK: Includes pavilion and indoor restrooms: \$75 Resident/\$100 Non Resident

MOLINE PARK: Includes pavilion area only: \$25 Resident/\$50 Non Resident

A \$50 DEPOSIT IS REQUIRED along with the rental fees for all park rentals. The amount of the deposit to be refunded will be determined by the Parks Commission upon inspection by the Park Commission and Building Maintenance Supervisor.

A separate check is required for the deposit and will be returned upon inspection.

Applicants must provide proof of liability insurance if inflatable bounce houses, amusement rides, dunk tanks, and food trucks, etc. are to be used at the park.

RULES AND REGULATIONS

- 1. Park hours are from 8:00 am to dusk**
- 2. Picnic tables are not to be removed from the park**
- 3. No open fires**
- 4. No overnight camping**
- 5. No alcohol**
- 6. No smoking**
- 7. No motorized vehicles in grassy areas or on ball fields, parking in designated areas only**
- 8. No fireworks**
- 9. No hunting**
- 10. Pets must be leashed and cleaned up afterwards**
- 11. Parents will be responsible for children's actions**
- 12. No destruction of natural surroundings**
- 13. No soliciting**
- 14. Vandalism will not be tolerated**
- 15. Tennis courts are not to be used for street hockey or rollerblading**
